2. Description of Materials and Articles

Unprinted, labelled, and printed moulded fibre egg cartons manufactured from post-industrial recycled paper (as defined in EN 643). The materials and articles are manufactured in accordance with good manufacturing practice (GMP) as per Regulation (EC) No 2023/2006.

3. Intended Use

The products listed in Section 2 are intended for contact with the following foodstuffs :

- Fresh shell eggs or boiled eggs in shell (as defined in Regulation (EC) No 853/2004), with the shell intact.

Permitted contact conditions :

- Long-term storage at room temperature or below.


Note: It is the responsibility of the recipient of this Declaration to ensure that the packaging is suitable for the intended processing and downstream use conditions.
